

Criminal Law Act with reference to Art. 416 bis ITALIAN ANTIMAFIA LEGISLATION CRIMINAL CODE

Criminal Law Act 1977 creates the offence of Conspiracy: "if any person agrees with any other person or persons on a course of conduct to be pursued". The punishment can be up to life imprisonment, and depends on the type of crime conspired towards.

Representation of the People Act with reference to Art. 416 ter ITALIAN ANTIMAFIA LEGISLATION CRIMINAL CODE Representation of the People Act, 1983, contains a variety of offences relating to elections.

The Elections Act with reference to Law 175/2010 BAN ON CARRYING OUT ELECTORAL PROPAGANDA FOR PERSONS SUBJECT TO PREVENTIVE MEASURES

The Elections Act 2022 introduced penalties and offences concerning "undue influence" and 'intimidation' during elections, including the ability for individuals to be 'disqualified' from campaigning (and for all "campaigners" to be officially recorded/employed).
